7 **A Resolution authorizing the County Executive to execute an amendment to the Moving**
8 **Ohio Forward Demolition Program Subrecipient Agreement with the City of Cuyahoga**
9 **Falls to increase the County's grant under said Agreement by \$10,000.00 to a total amount**
10 **of \$53,014.39, for the Executive's Department of Community and Economic Development,**
11 **and declaring an emergency.**

13 WHEREAS, the County and City of Cuyahoga Falls ("City") entered into a Moving Ohio
14 Forward Demolition Program Agreement ("Agreement") on September 24, 2012, as authorized
15 by Resolution No. 2012-310; and

16
17 WHEREAS, pursuant to Section IV of the Agreement, the County is providing the City
18 total funding of \$43,014.39 for demolition activities, which have been granted to the County by
19 the Summit County Land Revitalization Corporation, and the City is contributing an additional
20 \$10,000.00 in local funds; and

22 WHEREAS, the County desire to increase the amount granted to the City under the
23 Agreement by \$10,000.00, in order to provide for additional demolitions in the City and to
24 reallocate unused funds from other communities; and

26 WHEREAS, the County and City desire to amend the Agreement to provide the
27 aforementioned additional funds; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and is the best interest of the County to authorize the Executive to execute the
31 aforementioned amendment to the Agreement.

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

38 The County Executive is hereby authorized to execute an amendment to the Moving Ohio
39 Forward Demolition Program Subrecipient Agreement with the City of Cuyahoga Falls to
40 increase the County's grant under said Agreement by \$10,000.00 to a total amount of
41 \$53,014.39.

45 This Resolution is hereby declared an emergency in the interest of the health, safety, and
46 welfare of the citizens of the County of Summit and for the further reason of immediately
47 authorizing the County Executive to execute the amendment so that Moving Ohio Forward


