7 **A Resolution appropriating a new award of federal Workforce Investment Act funds, in**
8 **the amount of \$200,000.00, and carryover Workforce Investment Act funds, in the amount**
9 **of \$20,000.00, for a total of \$220,000.00, with no local cash match required, for the Youth**
10 **Employment for Success program, received from the Executive's Department of Job and**
11 **Family Services, for the period 7/1/13 through 6/30/14, for the Executive's Department of**
12 **Communications, and declaring an emergency.**

14 WHEREAS, Resolution No. 2013-287 confirmed the award by the Board of Control of a
15 professional service contract funded by a Workforce Investment Act ("WIA") grant in the
16 amount of \$200,000.00, awarded by the County Executives' Department of Job and Family
17 Services to the County of Summit Youth Employment for Success ("YES") program, for the
18 period 7/1/13 through 6/30/14; and

20 WHEREAS, the YES program has a carryover balance of \$20,000.00 in WIA funds
21 awarded in a prior period; and

23 WHEREAS, the goal of the youth employment program is to assist youth in overcoming
24 barriers and achieving academic and career goals by addressing their needs for work experience,
25 academic support, leadership development, personal guidance and follow up services; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to appropriate funds in the
29 amount of \$220,000.00;

SECTION 2

The County Fiscal Officer is hereby authorized and directed to effect the within appropriations.
