**A Resolution authorizing the County Executive to execute any documents necessary to accept an award by the Public Utilities Commission of Ohio of a 2014 hazardous material grant, for the period 6/12/13 through 6/12/14, in the amount of \$20,250.00, with no local cash match requirement, and appropriating the total of \$20,250.00 for training expenditures in the hazmat training grant, for the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety/Emergency Management Agency, and declaring an emergency.**

WHEREAS, the Public Utilities Commission of Ohio ("PUCO") has awarded a Fiscal Year 2014 PUCO training fund grant to the Executive's Department of Law, Insurance and Risk Management - Division of Public Safety/Emergency Management Agency ("EMA"), Special Operations Response Team, for the period 6/12/13 through 6/12/14, in the amount of \$20,250.00, with no local cash match requirement, to provide for hazmat operations; and

WHEREAS, the Fiscal Year 2014 PUCO grant has been awarded to the Summit County Special Operations Response Team - Hazmat IQ above the Line/Below the Line and Hazmat IQ Tox-Medic training to fire service personnel; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the grant from the PUCO, and to appropriate these grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept the award of a Fiscal Year 2014 Public Utilities Commission of Ohio ("PUCO") training fund grant award, for the period 6/12/13 through 6/12/14, in the amount of \$20,250.00, with no local cash match requirement.


