**A Resolution appropriating a carryover balance of \$9,559.03 in federal funds from the Ohio Department of Public Safety, for an Operating Vehicles Intoxicated Task Force grant, for the Sheriff, and declaring an emergency.**

WHEREAS, County Sheriff has a \$9,559.03 cash balance in a countywide Operating Vehicle Intoxicated ("OVI") Task Force grant from the Ohio Department of Public Safety, through the Governor's Highway Safety Office; and

WHEREAS, it is necessary to appropriate this carryover cash balance for 2013 operations; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned carryover appropriation of \$9,559.03 is necessary and in the best interest of the County of Summit,

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.


SECTION 5


