7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract renewal (first of two) with Goodwill Industries of Akron, Inc., for support**
9 **recruitment, intensive case management and subsidized employment opportunities, for the**
10 **period 7/1/13 through 6/30/14, in an amount not to exceed \$172,433.06, for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 24, 2013, awarded a
14 professional service contract renewal (first of two) with Goodwill Industries of Akron, Inc., for
15 support recruitment, intensive case management and subsidized employment opportunities, for
16 the period 7/1/13 through 6/30/14, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract renewal (first of
27 two) with Goodwill Industries of Akron, Inc., for support recruitment, intensive case
28 management and subsidized employment opportunities, for the period 7/1/13 through 6/30/14, in
29 an amount not to exceed \$172,433.06, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the renewal of the contract services effective 7/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

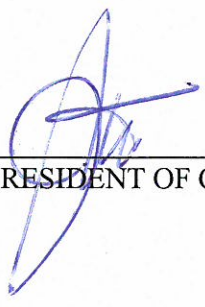

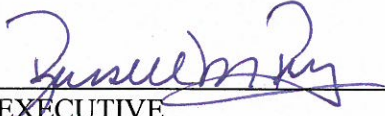
