7 **A Resolution amending Resolution No. 2013-284 to reflect the change in the vendor's name**
8 **from Provider Gateway Corporation to Mid-America Consulting Group, Inc., for the**
9 **Executive's Department of Job and Family Services, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2013-284, which confirmed
12 an award by the Board of Control of a renewal (first of two) of a professional service contract
13 with ProviderGateway Corporation for software maintenance services, for the period 7/1/13
14 through 6/30/14, approved by the IT Board 5/28/13, in an amount not to exceed \$62,500.00; and

16 WHEREAS, prior to the execution of the renewal, Provider Gateway Corporation
17 changed its name to Mid-America Consulting Group, Inc.; and

19 WHEREAS, it is necessary to amend Resolution No. 2013-284 to reflect the vendor's
20 name change; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to amend Resolution No.
24 2013-284 for the aforementioned reason;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 Resolution No. 2013-284 is hereby amended to replace all references to "Provider
32 Gateway Corporation" with "Mid-America Consulting Group, Inc." to reflect the change in the
33 vendor's name.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the citizens of the County of Summit and for the further purpose of immediately
39 amending Resolution No. 2013-284 to reflect the change in the vendor's name from Provider
40 Gateway Corporation to Mid-America Consulting Group, Inc.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
