7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Akron Legal News, Inc., to provide publication of notices for mortgage**
9 **foreclosures and other such notices as determined by the Court of Common Pleas, with**
10 **funds being collected up front by the Clerk of Courts, for the Executive's Department of**
11 **Law, Insurance and Risk Management, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 21, 2013, awarded a
14 professional service contract for publication of notices for mortgage foreclosures and such other
15 notices as determined by the Court of Common Pleas, subject to confirmation by County
16 Council; and

18 WHEREAS, the Court of Common Pleas establishes a fee schedule which includes the
19 cost of such notices, which cost is collected by the Clerk of Courts as part of the filing fees in
20 each case where such notice may be necessary; and

22 WHEREAS, the Court of Common Pleas has, by miscellaneous order, approved the use
23 of Akron Legal News, Inc., for the provision of such services; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned contract is necessary and in the best interest of the County of Summit;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The award by the Board of Control of a professional service contract with Akron Legal
34 News, Inc., to provide publication of notices for mortgage foreclosures and other such notices,
35 with funds being collected up front by the Clerk of Courts, is hereby confirmed and the County
36 Executive is hereby authorized to execute such contract.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 provide for the continued publication of legal notices for the Court of Common Pleas.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
