7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of a High Visibility Enforcement Overtime grant, from the Ohio**  
9 **Department of Public Safety, in the amount of \$77,718.38, with no local cash match**  
10 **requirement, for the period 10/1/13 through 9/30/14, and appropriating the grant funds, for**  
11 **the period 10/1/13 through 12/31/13, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County Sheriff's Office has been awarded \$77,718.38, with no local cash  
14 match requirement, from Ohio Department of Public Safety ("ODPS"), through its Office of  
15 Criminal Justice Services ("OCJS"), in order to operate the High Visibility Enforcement  
16 Overtime ("HVEO") program in the County of Summit, for the period 10/1/13 through 9/30/14;

19 WHEREAS, the HVEO grant has provided funding for the past 14 years to the Sheriff's  
20 Office for overtime in order to conduct high visibility enforcement, public awareness, and  
21 education in the County of Summit; and

23 WHEREAS, it is necessary to authorize the County Executive to execute any documents  
24 necessary to accept the award of the HVEO grant and appropriate grant funds for the period  
25 10/1/13 through 12/31/13; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
29 execute any documents necessary to accept the aforementioned grant, and to appropriate the  
30 grant funds, for the period 10/1/13 through 12/31/13;


