13 orders in a total amount not to cumulatively exceed \$44,658.00 with Wood Investments dba
14 Dynamerican ; and

17 that the aforementioned purchase orders are necessary and in the best interest of the County of
18 Summit;

25 The County Executive is hereby authorized to execute purchase orders with Wood
26 Investments dba Dynamerican for the replacement of failing septic systems, in a total amount not
27 to cumulatively exceed \$44,658.00.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide for the replacement of failing septic systems in Summit County.


