7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the University of Cincinnati for a reclaim service provider contract for**  
9 **required effective practices in community supervision booster training and family training,**  
10 **for the period 1/1/14 through 12/31/14, in an amount not to exceed \$40,000.00, for the**  
11 **Court of Common Pleas – Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 9, 2013, awarded a  
14 professional service contract with the University of Cincinnati for a reclaim service provider  
15 contract for required effective practices in community supervision booster training and family  
16 training, for the period 1/1/14 through 12/31/14, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with the University  
27 of Cincinnati for a reclaim service provider contract for required effective practices in  
28 community supervision booster training and family training, for the period 1/1/14 through  
29 12/31/14, in an amount not to exceed \$40,000.00, is hereby confirmed and the County Executive  
30 is hereby authorized to execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for the aforementioned training effective 1/1/14.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.


