7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the Court of Common Pleas Probate Division in calendar**
9 **year 2013 from APG Office Furnishings for office furnishings in the aggregate amount of**
10 **\$20,111.01, and authorizing additional purchases in an amount not to exceed \$14,888.99,**
11 **for a total aggregate amount not to exceed \$35,000.00, for calendar year 2013, for the**
12 **Court of Common Pleas Probate Division, and declaring an emergency.**

14 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
15 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
16 year, where no additional competitive quotes or bids have been taken, shall be made only upon
17 authorization of County Council; and

19 WHEREAS, the Department of Finance and Budget and the Board of Control have
20 previously approved purchases by the Court of Common Pleas Probate Division in calendar year
21 2013 in aggregate totaling \$20,111.01 with APG Office Furnishings for office furnishings; and

23 WHEREAS, the County Executive anticipates additional purchases will be made in
24 calendar year 2013 for office furnishings in an additional amount not to exceed \$14,888.99, for a
25 total aggregate amount not to exceed \$35,000.00 in calendar year 2013; and

27 WHEREAS this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County to ratify purchases by the Court of
29 Common Pleas Probate Division in calendar year 2013 from APG Office Furnishings for office
30 furnishings in the aggregate amount of \$20,111.01, and to authorize additional purchases in an
31 amount not to exceed \$14,888.99, for a total aggregate amount not to exceed \$35,000.00, for
32 calendar year 2013.
