14 purchase order with MCPc Technology Products and Solutions for purchase and installation

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

26 The award by the Board of Control of a purchase order with MCPc Technology Products
27 and Solutions for purchase and installation services for storage area network hardware
28 equipment, approved by the IT Bard 9/10/13, in an amount not to exceed \$30,116.53, is hereby
29 confirmed and the County Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the replacement of aging equipment.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
