7 **A Resolution confirming an award by the Board of Control of a purchase order with Xerox**
8 **Government Systems, LLC, for a three-year renewal of Banner maintenance, for the**
9 **period 1/1/14 through 12/31/16, as Sole Source, approved by the IT Board 10/15/13, in an**
10 **amount not to exceed \$191,798.36 per year, for a total amount not to exceed \$575,395.08,**
11 **for the Fiscal Officer, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 16, 2013, awarded a
14 purchase order with Xerox Government Systems, LLC, for a three-year renewal of Banner
15 maintenance, for the period 1/1/14 through 12/31/16, as Sole Source, approved by the IT Board
16 10/15/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase order with Xerox Government Systems,
27 LLC, for a three-year renewal of Banner maintenance, for the period 1/1/14 through 12/31/16, as
28 Sole Source, approved by the IT Board 10/15/13, in an amount not to exceed \$191,798.36 per
29 year, for a total amount not to exceed \$575,395.08, is hereby confirmed and the County
30 Executive is hereby authorized to execute such purchase order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide Banner maintenance effective 1/1/14.



