7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the County Executive for the Department of**
9 **Administrative Services, the Department of Environmental Services and the Department of**
10 **Job and Family Services in calendar year 2013 from Fred J. Crisp, Inc., for commercial**
11 **and industrial door repair services in the aggregate amount of \$26,063.73, and authorizing**
12 **additional purchases in an amount not to exceed \$8,936.27, for a total aggregate amount**
13 **not to exceed \$35,000.00, for calendar year 2013, for the Executive's Department of**
14 **Environmental Services, the Executive's Department of Administrative Services and the**
15 **Executive's Department of Job and Family Services, and declaring an emergency.**

17 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
18 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
19 year, where no additional competitive quotes or bids have been taken, shall be made only upon
20 authorization of County Council; and

22 WHEREAS, the Department of Finance and Budget and the Board of Control have
23 previously approved purchases by the County Executive for the Department of Administrative
24 Services, the Department of Environmental Services and the Department of Job and Family
25 Services in calendar year 2013 in aggregate totaling \$26,063.73 with Fred J. Crisp, Inc., for
26 commercial and industrial door repair services; and

28 WHEREAS, the County Executive anticipates additional purchases will be made in
29 calendar year 2013 for commercial and industrial door repair services in an additional amount
30 not to exceed \$8,936.27, for a total aggregate amount not to exceed \$35,000.00 in calendar year
31 2013; and

33 WHEREAS this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County to ratify purchases by the County
35 Executive for the Department of Administrative Services, the Department of Environmental
36 Services and the Department of Job and Family Services in calendar year 2013 from Fred J.
37 Crisp for commercial and industrial door repair services in the aggregate amount of \$26,063.73,
38 and to authorize additional purchases in an amount not to exceed \$8,936.27, for a total aggregate
39 amount not to exceed \$35,000.00, for calendar year 2013.

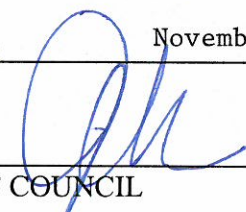

16 effect and be in force at the earliest time provided by law.

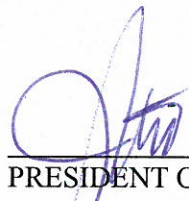

24 121.22 of the Ohio Revised Code.

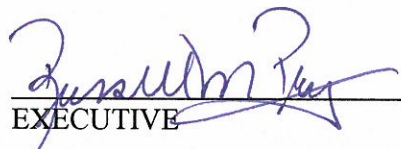
