7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Courtsmart Digital Systems for annual maintenance of the digital recording**  
9 **system, for the period 11/1/13 through 10/31/14, as Best Practical Source, approved by the**  
10 **IT Board 10/15/13, in an amount not to exceed \$49,088.00, for the Court of Common Pleas**  
11 **- Domestic Relations Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 23, 2013, awarded a  
14 professional service contract with Courtsmart Digital Systems for annual maintenance of the  
15 digital recording system, for the period 11/1/13 through 10/31/14, as Best Practical Source,  
16 approved by the IT Board 10/15/13, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Courtsmart  
27 Digital Systems for annual maintenance of the digital recording system, for the period 11/1/13  
28 through 10/31/14, as Best Practical Source, approved by the IT Board 10/15/13, in an amount not  
29 to exceed \$49,088.00, is hereby confirmed and the County Executive is hereby authorized to  
30 execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for maintenance of the court's digital recording system effective 11/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
