15 autopsies and 35 more Summit County cases than this time last year, which has required the use
16 of additional supplies and contract services above what was contemplated at the time the 2013
17 budget was adopted by this Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to appropriate the
21 aforementioned funds in the amount of \$10,000.00;
