7 **A Resolution confirming an award by the Board of Control of the second of four lease**  
8 **renewals with Bath Township for the seasonal use of salt storage facilities on Ira Road, in**  
9 **Council District 1, for the period 11/1/13 to 10/31/14, in an amount not to exceed \$7,200.00,**  
10 **for the Engineer, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2013-157, which amended  
13 the lease renewal terms with Bath Township for the seasonal use of salt storage facilities on Ira  
14 Road, in Council District 1; and

16 WHEREAS, this Council previously adopted Resolution No. 2011-486, which confirmed  
17 the award by the Board of Control of a lease with Bath Township for the seasonal use of salt  
18 storage facilities on Ira Road, in Council District 1, for the period 11/1/11 to 10/31/12; and

20 WHEREAS, the Board of Control, at its meeting held November 13, 2013, awarded the  
21 second of four lease renewals with Bath Township for the seasonal use of salt storage facilities  
22 on Ira Road, in Council District 1, for the period 11/1/13 to 10/31/14, in an amount not to exceed  
23 \$7,200.00, subject to confirmation by County Council; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that the lease renewal is necessary and in the best interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The award by the Board of Control of the second of four lease renewals with Bath  
34 Township for the seasonal use of salt storage facilities on Ira Road, in Council District 1, for the  
35 period 11/1/13 to 10/31/14, in an amount not to exceed \$7,200.00 is hereby confirmed and the  
36 County Executive is hereby authorized to execute such lease renewal.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
42 provide for a necessary lease renewal to store salt in Bath Township and to pay the township  
43 before shutdown at the end of 2013.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
