7 **A Resolution authorizing the County Executive to award a grant to the City of Hudson, in**  
8 **the amount of \$60,000.00, from the Fiscal Year 2011 Metropolitan Medical Response**  
9 **System grant program funds, in Council District 3, for the Executive's Department of Law,**  
10 **Insurance and Risk Management - Division of Public Safety/Emergency Management**  
11 **Agency, and declaring an emergency.**

13 WHEREAS, the Summit County Emergency Management Agency ("EMA") receives  
14 Metropolitan Medical Response System ("MMRS") funds on an annual basis to provide  
15 capabilities to better mitigate, prepare, respond and recover from an act of terrorism and other  
16 disasters within the medical and first responder communities; and

17  
18 WHEREAS, the City of Hudson requested Fiscal Year 2011 MMRS funding, in the  
19 amount of \$60,000.00, to assist with the purchase of radios in order to join the Summit  
20 County/Akron 800 MHz Regional Radio System; and

21  
22 WHEREAS, the Summit County Domestic Preparedness Steering Committee, the grant's  
23 oversight committee, has previously recommended approval of this award; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County to authorize the County Executive to  
27 award the aforementioned grant to the City of Hudson;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

34 The County Executive is hereby authorized to make a grant award to the City of Hudson,  
35 in the amount of \$60,000.00, from the Fiscal Year 2011 Metropolitan Medical Response System  
36 ("MMRS") grant program funds.

38 SECTION 2

40 This Resolution is declared an emergency in the interest of the health, safety and welfare  
41 of the citizens of the County of Summit and for the further purpose of immediately awarding  
42 grant funds in order to make radio purchases to provide interoperability on the county-wide radio  
43 system and ensure expenditures are made within the grant period.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
