7 **An Ordinance amending Chapter 923 of the Codified Ordinances of the County of Summit,**  
8 **entitled “Fees and User Charge System,” to extend the current 2013 sewer charges,**  
9 **surcharges and fees into 2014, for the Executive’s Department of Environmental Services,**  
10 **and declaring an emergency.**

11  
12 WHEREAS, in Ordinance No. 2006-550, the County Council amended certain sections  
13 of Chapter 923 of the Codified Ordinances of the County of Summit, entitled “Fees and User  
14 Charge System,” and set the various user charges, surcharges and fees for the Summit County  
15 Metropolitan Sewer District, administered by the Executive’s Department of Environmental  
16 Services; and

18 WHEREAS, Chapter 923 of the Codified Ordinances of the County of Summit currently  
19 contains user charges, surcharges and fees for calendar years 2007 through 2013; and

20  
21 WHEREAS, it is necessary to set all user charges, surcharges and fees in Chapter 923 for  
22 the year 2014; and

23  
24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the of the County of Summit that the user charges,  
26 surcharges and fees contained in Chapter 923 of the Codified Ordinances of the County of  
27 Summit should remain at the same rates and amounts in the year 2014 as they are for the current  
28 year 2013; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County of Summit to amend Sections 923.01,  
32 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified Ordinances of the County of  
33 Summit to implement said extension of the user charges, surcharges and fees;

35 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
36 of Ohio, that:

40 Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
41 Ordinances of the County of Summit are hereby amended as shown on Exhibit A, attached  
42 hereto and incorporated herein as if fully restated.

46 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
47 welfare of the citizens of the County of Summit, and for the further reason of immediately  
48 amending Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
49 Ordinances of the County of Summit, in order to immediately implement the user charges,  
50 surcharges and fees for the Summit County Metropolitan Sewer District for the year 2014.

7 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
8 effect and be in force at the earliest time provided by law.

13 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all

16 121.22 of the Ohio Revised Code.
