7 **A Resolution adopting the Solid Waste Management Plan for the Summit-Akron Solid**
8 **Waste Management Authority, for the Executive, and declaring an emergency.**

10 WHEREAS, Summit County is located within the territorial jurisdiction of the Summit-
11 Akron Solid Waste Management Authority; and

13 WHEREAS, the Summit-Akron Solid Waste Management Authority Board of Trustees
14 prepared and adopted a final draft of the Solid Waste Management Plan ("Final Draft Plan") in
15 accordance with Sections 3734.53, 3734.54 and 3734.55 of the Ohio Revised Code; and

17 WHEREAS, the Summit-Akron Solid Waste Management Authority has provided a copy
18 of the Final Draft Plan for ratification to each of the legislative authorities within its territorial
19 jurisdiction; and

21 WHEREAS, this Council, on behalf of the County of Summit, must decide whether it
22 approves of said Solid Waste Management Plan within ninety days of receipt of the Final Draft
23 Plan;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that adopting the Solid Waste Management Plan for the Summit-Akron Solid Waste
27 Management Authority is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 This Council, on behalf of the County of Summit, approves the Summit-Akron Solid
35 Waste Management Authority Solid Waste Management Plan.

39 The Clerk of Council is hereby directed to send a copy of this Resolution to the attention
40 of Yolanda Walker, the Executive Director of the Summit-Akron Solid Waste Management
41 Authority.

46 welfare of the citizens of the County of Summit, and for the further reason to immediately
47 approve the Summit-Akron Solid Waste Authority Solid Waste Management Plan in the time
