7 **A Resolution confirming an award by the Board of Control of a renewal of a purchase**  
8 **contract (fourth of five) with Aramark Correctional Services for jail inmate food services,**  
9 **for the period 12/1/13 through 11/30/14, in an amount not to exceed \$750,000.00, for the**  
10 **Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting November 20, 2013, awarded a renewal  
13 of a purchase contract (fourth of five) with Aramark Correctional Services for jail inmate food  
14 services, for the period 12/1/13 through 11/30/14, subject to confirmation by County Council;  
15 and,

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the purchase contract renewal is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a renewal of a purchase contract (fourth of five)  
26 with Aramark Correctional Services for jail inmate food services, for the period 12/1/13 through  
27 11/30/14, in an amount not to exceed \$750,000.00, is hereby confirmed and the County  
28 Executive is hereby authorized to execute such renewal.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further reason to immediately  
34 provide jail inmate food services effective 12/1/13.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

42 SECTION 4

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.

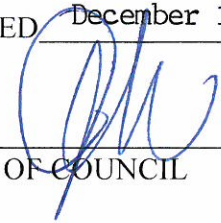
