7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of federal funds by the Ohio Department of Youth Services of a 2013**
9 **Juvenile Accountability Block Grant, for the period 1/1/14 through 12/31/14, in the amount**
10 **of \$14,205.00, with a local cash match requirement of \$46,729.00, and appropriating the**
11 **total funds in the amount of \$60,934.00 for expenditures in 2014, for the Court of Common**
12 **Pleas – Juvenile Division and declaring an emergency.**

14 WHEREAS, the Ohio Department of Youth Services has awarded a 2013 Juvenile
15 Accountability Block Grant (“JABG”) of federal funds to the Juvenile Court, for the period
16 1/1/14 through 12/31/14, in the amount of \$14,205.00, with a local cash match requirement of
17 \$46,729.00, to provide for salaries and benefits of a probation officer; and

18
19 WHEREAS, the JABG-funded probation officer will provide probation services to higher
20 at-risk youth in order to reduce delinquency and recidivism among this population; and

21
22 WHEREAS, the JABG’s local cash match requirement of \$46,729.00 will be provided by
23 the Juvenile Court’s RECLAIM funds; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from the Ohio
28 Department of Youth Services, and to appropriate funds in the total amount of \$60,934.00 for
29 expenditures in 2014;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award of a 2013 Juvenile Accountability Block Grant (“JABG”) award from the Ohio
38 Department of Youth Services, for the period 1/1/14 through 12/31/14, in the amount of
39 \$14,205.00, with a \$46,729.00 local cash match requirement.
