7 **A Resolution appropriating funds in the amount of \$2,400.00 for the Psycho-Diagnostic**  
8 **Clinic, with no local cash match requirement, for the period 9/1/13 through 12/31/13, for**  
9 **the Court of Common Pleas – General Division, and declaring an emergency.**

11 WHEREAS, the Psycho-Diagnostic Clinic is needed to provide court-ordered evaluations  
12 in criminal cases, and the aforementioned monies will be used to reimburse the Clinic for  
13 expenditures; and

15 WHEREAS, the Psycho-Diagnostic Clinic received funds from Portage, Medina, Geauga  
16 and Stark counties for performing state ordered psychological evaluations; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that it is necessary and in the best interest of the County of Summit to appropriate the  
20 aforementioned grant funds in the total amount of \$2,400.00, with no local cash match  
21 requirement;

16 Section 121.22 of the Ohio Revised Code.


