7 **A Resolution confirming an award by the Board of Control of a purchase contract with Q-**
8 **Matic Corporation for queuing management system maintenance and support services, for**
9 **the period 1/1/14 through 12/31/14, approved by the IT Board 11/19/13, as Best Practical**
10 **Source, in an amount not to exceed \$31,763.52, for the Executive's Department of Job and**
11 **Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 20, 2013, awarded a
14 purchase contract with Q-Matic Corporation for queuing management system maintenance and
15 support services, for the period 1/1/14 through 12/31/14, approved by the IT Board 11/19/13, as
16 Best Practical Source, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Q-Matic Corporation for
27 queuing management system maintenance and support services, for the period 1/1/14 through
28 12/31/14, approved by the IT Board 11/19/13, as Best Practical Source, in an amount not to
29 exceed \$31,763.52, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide queuing management system maintenance and support services effective 1/1/14.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

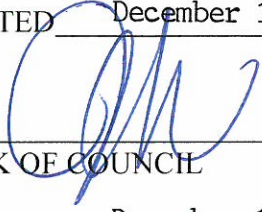

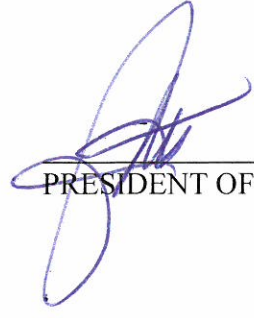

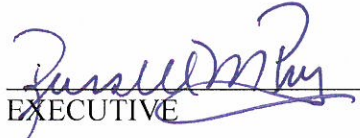
