7 **A Resolution confirming an award by the Board of Control of a renewal (third of four) of a**
8 **lease agreement with First Church of Christ, Scientist, for 30 parking spaces located at 90**
9 **North Summit Street, Akron, Ohio 44308, in Council District 4, for the period 12/1/13**
10 **through 11/30/14, in an amount not to exceed \$3,000.00, for the Executive's Department of**
11 **Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 20, 2013, awarded a
14 renewal (third of four) of a lease agreement with First Church of Christ, Scientist, for 30 parking
15 spaces located at 90 North Summit Street, Akron, Ohio 44308, in Council District 4, for the
16 period 12/1/13 through 11/30/14, subject to confirmation by County Council; and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that
19 the lease agreement renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a renewal (third of four) of a lease agreement with
27 First Church of Christ, Scientist, for 30 parking spaces located at 90 North Summit Street,
28 Akron, Ohio 44308, in Council District 4, for the period 12/1/13 to 11/30/14, in an amount not to
29 exceed \$3,000.00, is hereby confirmed and the County Executive is hereby authorized to execute
30 such lease agreement renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further purpose to immediately
36 authorize the renewal of a necessary lease agreement effective 12/1/13.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,




