7 **A Resolution authorizing the County Executive to execute an amendment to the collective**
8 **bargaining agreement between Local 3885, Child Support Enforcement Agency, and Ohio**
9 **Council 8 of the American Federation of State, County and Municipal Employees, AFL-**
10 **CIO, the County Prosecutor and the Executive authorizing a one and one-half percent**
11 **(1.5%) salary increase for the third year of the agreement, from October 1, 2013 through**
12 **September 30, 2014, for the Executive's Department of Human Resources, and declaring**
13 **an emergency.**

15 WHEREAS, pursuant to Resolution No. 2011-162, this Council authorized the County
16 Executive to execute a collective bargaining agreement between Local 3885, Child Support
17 Enforcement Agency, and Ohio Council 8 of the American Federation of State, County and
18 Municipal Employees, AFL-CIO ("AFSCME"), the County Prosecutor and the Executive, for a
19 term from October 1, 2011 through September 30, 2014; and

21 WHEREAS, the aforementioned collective bargaining agreement provides for a wage
22 reopener in the third year of the agreement, from October 1, 2013 through March 31, 2014; and

23
24 WHEREAS, the County Executive has negotiated a pay increase of one and one-half
25 percent (1.5%) for the third year of the aforementioned collective bargaining agreement,
26 consistent with the pattern established in other collective bargaining agreements within the last
27 year.

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 execute the aforementioned amendment to the collective bargaining agreement;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The County Executive is hereby authorized to execute an amendment to the collective
39 bargaining agreement between Local 3885, Child Support Enforcement Agency, and Ohio
40 Council 8 of the American Federation of State, County and Municipal Employees, AFL-CIO
41 ("AFSCME"), the County Prosecutor and the Executive, authorizing a one and one-half percent
42 (1.5%) pay increase for the third year of the agreement, from October 1, 2013 through September
43 30, 2014.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and
48 welfare of the citizens of the County of Summit and for the further purpose of authorizing a
49 timely necessary amendment to the collective bargaining agreement between Local 3885, Child
50 Enforcement Agency and Ohio Council 8 of AFSCME, the Prosecutor and the Executive.
