27 for the Federal Fiscal Year 2014 Family Drug Court Implementation Project grant, for the period
28 10/1/13 through 9/30/14, per attached Exhibit A, in a total amount not to exceed \$85,488.00, is
29 hereby confirmed and the County Executive is hereby authorized to execute such contracts.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for Family Drug Court service providers effective 10/1/13.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
