7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the City of Akron to provide homeless prevention services, for the period**
9 **10/1/13 through 9/30/14, in an amount not to exceed \$175,000.00, for the Executive's**
10 **Department of Job and Family Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held August 21, 2013, awarded an
13 intergovernmental agreement with the City of Akron to provide homeless prevention services,
14 for the period 10/1/13 through 9/30/14, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the agreement is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of an intergovernmental agreement with the City of
25 Akron to provide homeless prevention services, for the period 10/1/13 through 9/30/14, in an
26 amount not to exceed \$175,000.00, is hereby confirmed and the County Executive is hereby
27 authorized to execute such agreement.

29 SECTION 2



38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
