13 WHEREAS, the Board of Control, at its meeting held December 11, 2013, awarded a
14 professional service contract renewal (first of two) with Courtview Justice Solutions, Inc., for
15 case management system maintenance and support, for the period 1/1/14 through 12/31/14,
16 approved by the IT Board 12/3/13, as Best Practical Source, subject to confirmation by County
17 Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract renewal is necessary and in the best interest of the County of Summit;

27 The award by the Board of Control of a professional service contract renewal (first of
28 two) with Courtview Justice Solutions, Inc., for case management system maintenance and
29 support, for the period 1/1/14 through 12/31/14, approved by the IT Board 12/3/13, as Best
30 Practical Source, in an amount not to exceed \$55,024.00, is hereby confirmed and the County
31 Executive is hereby authorized to execute such contract renewal.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide for case management system maintenance and support effective 1/1/14.

42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.






