7 **A Resolution appropriating funds for the Court of Common Pleas – General Division, in**  
8 **the amount of \$161,022.00 in carryover balances in a Probation Improvement and**  
9 **Incentive grant from the Ohio Department of Rehabilitation and Correction, for calendar**  
10 **year 2014, for the Court of Common Pleas - General Division, and declaring an emergency.**

12 WHEREAS, the Summit County Court of Common Pleas – General Division has  
13 carryover balances in a Probation Improvement and Incentive grant received from the Ohio  
14 Department of Rehabilitation and Correction to provide additional programming for probationers  
15 in order to assist in their reintegration into the community, in the amount of \$161,022.00, with no  
16 local cash match requirement, for Fiscal Years 2014 and 2015; and

18 WHEREAS, it is necessary to appropriate these carryover funds from 2013 for 2014  
19 operations; and

16 121.22 of the Ohio Revised Code.


