7 **A Resolution appropriating funds for the County Prosecutor in the amount of \$398,294.85,**  
8 **in carryover balances in various grants for calendar year 2014, for the Prosecutor, and**  
9 **declaring an emergency.**

11 WHEREAS, the County Prosecutor has a Domestic Violence federal 2011-2015 grant  
12 with a carryover balance totaling \$25,639.33; and

13  
14 WHEREAS, the County Prosecutor has grant carryover balances in a federal Victims of  
15 Crime Act grant in the amount of \$70,583.35 and the State Victims Assistance Award in the  
16 amount of \$3,470.00, from the Ohio Attorney General's Office, with an end date of 9/30/14; and

17  
18 WHEREAS, the County Prosecutor has carryover balances in the Direct Indictment  
19 Program of \$294,039.57, funded by participating Summit County municipalities; and

20  
21 WHEREAS, the County Prosecutor has carryovers balances in the Child Support  
22 Enforcement Agency's Special Improvement Project Grant from the U.S. Department of Health  
23 and Human Services in the amount of \$4,562.60; and

25 WHEREAS, it is necessary to appropriate these carryover balances from 2013 for 2014  
26 operations; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that the appropriation of aforementioned carryover funds is necessary and in the best interest of  
30 the County of Summit;
