8 **\$285,664.00 from the State of Ohio, and Medicaid Enhanced federal match funds in the**
9 **amount of \$856,993.00, for a total of \$1,142,657.00, with no local cash match requirement,**
10 **for the period 10/1/13 through 6/30/14, for the Executive’s Department of Job and Family**
11 **Services, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Job and Family Services (“ODJFS”) has awarded a
14 Medicaid Enhanced grant of \$285,664.00 and \$856,993.00 in additional federal matched funds
15 to the Executive’s Department of Job and Family Services (“SCDJFS”), for a total amount of
16 \$1,142,657.00, for the period 10/1/13 through 6/30/14, with no local cash match requirement;

19 WHEREAS, the additional funding is to provide support for SCDJFS’s implementation
20 of and conversion to a state sponsored enhanced Medicaid eligibility system; and

24 aforementioned funds in the amount of \$1,142,657.00;


