7 **A Resolution amending Resolution No. 2013-449, to authorize the County Executive to**
8 **advertise for bids for the purchase of two utility service bodies for Ford F-550 chassis cabs,**
9 **for an estimated cost not to exceed \$35,000.00 each, for a total of \$70,000.00, for the**
10 **Executive's Department of Environmental Services, and declaring an emergency.**

11
12 WHEREAS, in Resolution No. 2013-449, County Council authorized the County
13 Executive to advertise for bids for the purchase of two utility service bodies for Ford F-550
14 chassis cabs, for an estimated total cost not to exceed \$35,000.00; and

15
16 WHEREAS, the above \$35,000.00 estimated cost was for a single utility service bodies
17 rather than two utility service bodies; and

18
19 WHEREAS, in order to properly advertise for bids, Resolution No. 2013-449 must be
20 amended to reflect the actual estimated total cost for the purchase of two utility service bodies at
21 \$70,000.00; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that amending Resolution No. 2013-449 in the manner described is necessary and in the best
25 interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that;

30 SECTION 1

32 Section 1 of Resolution No. 2013-449 is hereby amended in its entirety to state "The
33 County Executive is authorized to advertise for bids for the purchase of two utility service bodies
34 for Ford F-550 chassis cabs, at an estimated cost of \$35,000.00 each, for a total cost not to
35 exceed \$70,000.00, for the Executive's Department of Environmental Services ("DOES"). The
36 technical specifications attached to Resolution No. 2013-449 as Exhibit A remain unchanged.

38 SECTION 2

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare
41 of the citizens of the County of Summit, and for the further reason that it authorizes the
42 Executive to immediately advertise for bids for the utility service bodies, needed to properly
43 equip two new Ford F-550 trucks in the DOES fleet.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
