7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award by the Ohio Department of Youth Services of a federally funded 2014**
9 **Juvenile Accountability Block Grant, for the period 2/1/14 through 9/30/14, in the amount**
10 **of \$12,275.00, with no local cash match requirement, and appropriating grant funds for**
11 **expenditures in 2014, for the Court of Common Pleas – Juvenile Division and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Department of Youth Services has awarded a federally funded
15 2014 Juvenile Accountability Block Grant (“JABG”) to the Juvenile Court, for the period 2/1/14
16 through 9/30/14, in the amount of \$12,275.00, with no local cash match requirement, to provide
17 for a pilot program project to impact minority arrests in Summit County; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
21 execute any documents necessary to accept the award of the aforementioned JABG from the
22 Ohio Department of Youth Services, and to appropriate these grant funds;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The County Executive is hereby authorized to execute any documents necessary to accept
30 the award of a federally funded 2014 Juvenile Accountability Block Grant (“JABG”) from the
31 Ohio Department of Youth Services, for the period 2/1/14 through 9/30/14, in the amount of
32 \$12,275.00, with no local cash match requirement.
