7 **A Resolution confirming an award by the Board of Control of a super blanket purchase**
8 **order with Ports Petroleum for diesel and unleaded fuel for general fleet operation, under**
9 **CUE pricing, for fiscal year 2014, in an amount not to exceed \$100,000.00, for the**
10 **Executive's Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 5, 2014, awarded a super
13 blanket purchase order with Ports Petroleum for diesel and unleaded fuel for general fleet
14 operation, under CUE pricing, for fiscal year 2014, subject to confirmation by County Council;

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the super blanket purchase order is necessary and in the best interest of the County of
19 Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a super blanket purchase order with Ports
27 Petroleum for diesel and unleaded fuel for general fleet operation, under CUE pricing, for fiscal
28 year 2014, in an amount not to exceed \$100,000.00, is hereby confirmed and the County
29 Executive is hereby authorized to execute such super blanket purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide diesel and unleaded fuel for general fleet operation in 2014.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.




