7 **A Resolution appropriating funds for the Executive’s Department Job and Family Services**  
8 **in the amount of \$190,215.12, in carryover grants for calendar year 2014, for the**

11 WHEREAS, the Summit County Department of Job and Family Services (“SCDJFS”)  
12 has grant carryover funds in the amount of \$190,215.12, for the Connecting the Dots-Temporary  
13 Assistance for Needy Families (“TANF”) Demo grant from the Ohio Department of Job and  
14 Family Services (“ODJFS”) in federal funds; and

16 WHEREAS, it is necessary to appropriate these carryover balances from 2013 for 2014  
17 operations; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the appropriation of aforementioned carryover funds is necessary and in the best interest of  
21 the County of Summit;




