14 professional service contract with Kronos, Inc., to provide software support services, mobile
15 promotion support services, equipment support services and educational services, for the period
16 3/21/14 through 3/20/15, approved by the IT Board 1/21/14, as Best Practical Source, in Summit
17 County, subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract is necessary and in the best interest of the County of Summit;

27 The award by the Board of Control of a professional service contract with Kronos, Inc.,
28 to provide software support services, mobile promotion support services, equipment support
29 services and educational services, for the period 3/21/14 through 3/20/15, approved by the IT
30 Board 1/21/14, as Best Practical Source, in an amount not to exceed \$79,023.76, is hereby
31 confirmed and the County Executive is hereby authorized to execute such contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide software support services, mobile promotion support services, equipment support
38 services and educational services effective 3/21/14.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

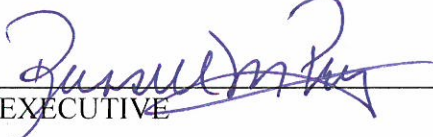
