7 **A Resolution authorizing the County Executive to advertise for bids for the improvement**
8 **of the Ravenna Road Bridge over Tinker's Creek, located in Twinsburg Township, in**
9 **Council District 1, for an estimated total cost not to exceed \$2,100,000.00, for the Engineer,**
10 **and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the improvement of
16 the Ravenna Road Bridge over Tinker's Creek (TWT-012-0140) (SUM-CR 12-1.40), PID
17 92240, located in Twinsburg Township, in Council District 1; and

19 WHEREAS, a copy of the specifications are on file with the Clerk of Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the aforementioned project;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for the improvement of the
31 Ravenna Road Bridge over Tinker's Creek (TWT-012-0140) (SUM-CR 12-1.40), PID 92240,
32 located in Twinsburg Township, in Council District 1, for an estimated total cost not to exceed
33 \$2,100,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare
38 of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the improvement to the Ravenna Road Bridge
40 over Tinker's Creek, located in Twinsburg Township, in Council District 1, in 2014.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
