7 **A Resolution approving the time, place and expense of the County Engineer's annual**
8 **meeting of county and township authorities on May 6, 2014, at the Tangier Restaurant, in**
9 **Council District 5, in an amount not to exceed \$3,500.00, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, Section 5543.06 of the Ohio Revised Code mandates that the County
13 Engineer annually call a meeting of all county and township authorities who are directly
14 involved with the construction and repair of roads and bridges within the County, at a time and
15 place approved by this Council; and

16
17 WHEREAS, the Summit County Township Association has requested that the Engineer
18 hold this meeting on Tuesday, May 6, 2014, at 5:30 p.m.; and

19
20 WHEREAS, facilities at the Tangier Restaurant at 532 West Market Street in Akron,
21 Ohio, have been proposed by the Engineer as an appropriate place to hold this meeting; and

22
23 WHEREAS, Prosecutor's Opinion 89-084 concludes that the cost of a dinner meeting for
24 the event is a proper expenditure, payable from the Engineer's road and bridge funds; and

25
26 WHEREAS, Section 177.25 (b) of the Codified Ordinances of the County of Summit
27 permits certain entities, including the Engineer, to make expenditures not exceeding \$2,000.00
28 annually for employee training, organization strategic planning meetings and meetings of boards
29 and commissions; and

30
31 WHEREAS, Section 177.25 (c) of the Codified Ordinances of the County of Summit
32 requires Council approval for all expenditures for hospitality items for purposes other than the
33 aforementioned purposes; and

35 WHEREAS, the Engineer intends to expend funds in an amount not to exceed \$3,500.00
36 for the aforementioned meeting, which is not included in the categories for which an annual
37 \$2,000.00 expenditure without Council approval is authorized; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that approving the time and place of the Engineer's 2014 annual meeting of county and township
41 authorities, and approving expenditures in an amount not to exceed \$3,500.00, is necessary and
42 in the best interest of the County of Summit;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
45 of Ohio, that:

49 County Council hereby approves the time and place of the Engineer's annual meeting of
