7 **A Resolution authorizing the County Executive to execute an addendum to a one-year**  
8 **policing contract with the County of Summit Developmental Disabilities Board, to provide**  
9 **one Sheriff's Deputy and one shift vehicle, for the extended period 3/1/14 through 5/31/14,**  
10 **in Council District 6, for \$7,859.64 per month or \$23,578.92 for the extended period, for a**  
11 **new total amount of \$117,894.57, for the Sheriff, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2013-122, which authorized  
14 the County Executive to execute a one-year policing contract with the County of Summit  
15 Developmental Disabilities Board ("DD Board"), to provide one Sheriff's Deputy and one shift  
16 vehicle, for the period 3/1/13 through 2/28/14, in Council District 6, in a total amount not to  
17 exceed \$94,315.65; and

18  
19 WHEREAS, the DD Board has requested that the Executive execute an addendum to the  
20 policing contract to extend it for the period 3/1/14 through 5/31/14; and

21  
22 WHEREAS, the DD Board has agreed to continue to pay the County the amount of  
23 \$7,859.64 per month for the extended period, for an additional amount of \$23,578.92, for a new  
24 total amount of \$117,894.57; and

25  
26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
28 execute the aforementioned addendum to the policing contract between the County and the DD  
29 Board;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that;

36 The County Executive is hereby authorized to execute an addendum to a one-year  
37 policing contract with the County of Summit Developmental Disabilities Board ("DD Board"),  
38 to provide one Sheriff's Deputy and one shift vehicle, for the extended period 3/1/14 through  
39 5/31/14, in Council District 6, for \$7,859.64 per month or \$23,578.92 for the extended period,  
40 for a new total amount of \$117,894.57.

44 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
45 welfare of the citizens of the County of Summit and for the further purpose of immediately  
46 providing necessary policing to County of Summit Developmental Disabilities Board effective  
47 3/1/14 to 5/31/14.
