7 **A Resolution confirming an award by the Board of Control of a purchase contract with ID**
8 **Networks for seven LiveScan fingerprint machines, approved by the IT Board 2/25/14, in a**
9 **total amount not to exceed \$108,465.00, for the Executive's Department of Law, Insurance**
10 **and Risk Management – Division of Public Safety/Emergency Management Agency, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 26, 2014, awarded a
14 purchase contract with ID Networks for seven LiveScan fingerprint machines, approved by the
15 IT Board 2/25/14, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the purchase contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a purchase contract with ID Networks for seven
26 LiveScan fingerprint machines, approved by the IT Board 2/25/14, in a total amount not to
27 exceed \$108,465.00, is hereby confirmed and the County Executive is hereby authorized to
28 execute such purchase contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the fingerprint machines in 2014.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.


