12 Division of Public Safety, has carryover grant funding for the Community Based Correctional
13 Facility ("CBCF") grant program from the Ohio Department of Rehabilitation and Correction, in
14 the amount of \$51,456.00; and

16 WHEREAS, the Executive's Department of Law, Insurance and Risk Management -
17 Division of Public Safety, has carryover grant funding for the Adult Drug Court Program from
18 the U.S. Department of Justice, Bureau of Justice Assistance, in the amount of \$5,600.00; and

20 WHEREAS, it is necessary to appropriate these carryover funds from 2013 totaling
21 \$57,056.00 for 2014 operations, and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to appropriate the
25 aforementioned carryover funds in the amount of \$57,056.00;
