7 **A Resolution authorizing the County Executive to advertise for bids for Phase 2 of the**
8 **Riverview Road Improvement Project, in Council District 1, for an estimated total cost not**
9 **to exceed \$635,606.05, for the Engineer, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

14 WHEREAS, the County Executive wishes to advertise for bids for Phase 2 of the
15 Riverview Road Improvement Project, in Council District 1, and

17 WHEREAS, a copy of the specifications are on file with the Clerk of Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that is necessary and in the best interest of the County of Summit to authorize the Executive to
21 advertise for bids for the aforementioned project;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that;

28 The County Executive is authorized to advertise for bids for Phase 2 of the Riverview
29 Road Improvement Project, in Council District 1, for an estimated total cost not to exceed
30 \$635,606.05.

34 This Resolution is declared an emergency in the interest of the health, safety, and welfare
35 of the citizens of the County of Summit, and for the further reason that it authorizes the
36 Executive to immediately advertise for bids for Phase 2 of the Riverview Road Improvement
37 Project in Council District 1 in 2014.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.
