14 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
15 requires this Council's authorization for the County Executive to advertise for bids; and

17 WHEREAS, the County Executive wishes to advertise for bids for a vendor to act as the
18 employer of record and provide payroll services for the 2014 Summer Youth Employment
19 Program, for the period 5/15/14 through 9/30/14, per attached Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the aforementioned services;

34 youth wages.
