7 **A Resolution appropriating funds in the amount of \$12,436.52 for the administration of the**
8 **distribution of fuel fund assistance through the 2012-2014 Fuel Fund Grant Program**
9 **established by the Ohio Edison Company, the Cleveland Electric Illuminating Company**
10 **and the Toledo Edison Company, to assist low income electric customers, for the**
11 **Executive's Department of Community and Economic Development, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Edison Company, the Cleveland Electric Illuminating Company
15 and the Toledo Edison Company have agreed to provide funding, as approved by the Public
16 Utilities Commission of Ohio in Case No. 08-935-EL-SSO, to implement and support a fuel fund
17 program to provide financial assistance to eligible customers toward payment of their electric
18 bills; and

20 WHEREAS, this Council previously adopted Resolution No. 2012-088, which authorized
21 the Executive to execute any documents necessary to act as an agent for the distribution of fuel
22 fund assistance through the 2012-2014 Fuel Fund Grant Program; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information
25 that appropriating grant funds for the distribution of fuel fund assistance through the 2012-2014
26 Fuel Fund Grant Program is necessary and in the best interest of the County of Summit;
