7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award from the Ohio Department of Public Safety's Office of Criminal Justice**  
9 **Services of a Drug Law Enforcement Fund grant, in the amount of \$250,000.00, with a**  
10 **25% local cash match requirement of \$83,333.33, for the period 2/1/14 through 1/31/15,**  
11 **and appropriating the \$333,333.33, for Fiscal Year 2014, for the Sheriff, and declaring an**  
12 **emergency.**

14 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services  
15 ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Law Enforcement Fund ("DLEF")  
16 grant in the amount of \$250,000.00, with a 25% local cash match requirement of \$83,333.33, for  
17 the period 2/1/14 through 1/31/15; and

19 WHEREAS, the DLEF grant will fund a countywide drug unit task force which will  
20 specifically target the manufacture, distribution and acquisition of illegal drugs in Summit  
21 County; and

23 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit  
24 County Drug Unit checking account; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
28 execute any documents necessary to accept the award of the aforementioned DLEF grant from  
29 the ODPS-OCJS, and to appropriate grant funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept  
37 the award by the Ohio Department of Public Safety's Office of Criminal Justice Services  
38 ("ODPS-OCJS") of a Drug Law Enforcement Fund ("DLEF") grant in the amount of  
39 \$250,000.00, with a 25% local cash match requirement of \$83,333.33, for the period 2/1/14  
40 through 1/31/15.
