7 **A Resolution authorizing the County Executive to establish the intersection of Riverview**  
8 **Road and Boston Mills Road in Boston Township, in Council District 1, a four-way stop**  
9 **intersection, for the period 5/10/14 through 5/28/14, and thereafter reverting to a two-way**  
10 **stop intersection, with the stop signs installed for the eastbound and westbound Boston**  
11 **Mills Road traffic, for the Engineer, and declaring an emergency.**

12  
13 WHEREAS, the Section 5553.02 of the Ohio Revised Code grants authority to locate,  
14 alter, or vacate roads to the board of county commissioners, and;

15  
16 WHEREAS, Section 5553.04 of the Ohio Revised Code establishes the procedure for  
17 establishing, altering, or vacating roads, and;

18  
19 WHEREAS, the Cuyahoga Valley Scenic Railroad desires to celebrate the “Day Out  
20 With Thomas” event, and has asked the Engineer to assist in traffic control by establishing a  
21 four-way stop at the intersection at Riverview Road and Boston Mills Road due to the increased  
22 vehicular and pedestrian traffic anticipated during the time of this event;

23  
24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that establishing the intersection of Riverview Road and Boston Mills Road in Boston Township,  
26 in Council District 1, a four-way stop intersection, for the period 5/10/14 through 5/28/14, and  
27 thereafter reverting to a two-way stop intersection, with the stop signs installed for the eastbound  
28 and westbound Boston Mills Road traffic, is necessary and in the best interest of the County of  
29 Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

34 SECTION 1

36 The Summit County Executive is hereby authorized to establish the intersection of  
37 Riverview Road and Boston Mills Road a temporary four-way stop intersection for the period  
38 5/10/14 through 5/28/14, after which said intersection shall revert to a two-way stop intersection  
39 with the stop signs installed for the eastbound and westbound Boston Mills Road traffic.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and  
44 welfare of the citizens of the County of Summit, and for the further reason that it ensures safe  
45 travel for pedestrians and workers for the “Day Out With Thomas” event in Council District 1.

47 SECTION 3

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
51 effect and be in force at the earliest time provided by law.
