7 **A Resolution appropriating targeted diversion model incentive funds in the amount of**
8 **\$200,989.00, with no local cash match requirement, for development programs under the**
9 **SMART Ohio Pilot Funding Grant, for the Executive's Department of Insurance and Risk**
10 **Management – Division of Public Safety, and declaring an emergency.**

12 WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC")
13 has awarded to the County of Summit, a State Fiscal Year ("SFY") 2014 SMART Ohio Pilot
14 Funding Grant, in an amount not to exceed \$603,989.00, with no local cash match requirement,
15 for the period 3/1/14 through 6/30/16, to assist in diverting non-violent, felony offenders from
16 prison; and

18 WHEREAS, this Council previously adopted Resolution No. 2014-107, which authorized
19 the Executive to execute any documents necessary to accept an award from the State of Ohio
20 Department of Rehabilitation and Correction of the SFY 2014 SMART Ohio Program grant, in
21 an amount not to exceed \$603,989.00; and

24 that the aforementioned appropriations are necessary and in the best interest of the County of
25 Summit;
