7 **A Resolution authorizing the County Executive to advertise for bids for the Ohio Building**
8 **Heating, Ventilation and Air Conditioning Upgrade Project at 195 South Main Street,**
9 **Akron, Ohio 44308, in Council District 4, for an estimated total cost not to exceed**
10 **\$43,000.00, for the Executive's Department of Administrative Services – Physical Plants,**
11 **and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for the Ohio Building
17 Heating, Ventilation and Air Conditioning Upgrade Project at 195 South Main Street, Akron,
18 Ohio 44308, in Council District 4; and

20 WHEREAS, a copy of the bid specifications are on file in the Clerk of Council's office;

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the aforementioned project;

32 The County Executive is authorized to advertise for bids for the Ohio Building Heating,
33 Ventilation and Air Conditioning Upgrade Project at 195 South Main Street, Akron, Ohio 44308,
34 in Council District 4, for an estimated total cost not to exceed \$43,000.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare
39 of the citizens of the County of Summit, and for the further reason that it authorizes the
40 Executive to immediately advertise for bids for the Ohio Building Heating, Ventilation and Air
41 Conditioning Project and to replace the last antiquated air handler in the Ohio Building.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
