7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award from the State of Ohio Department of Rehabilitation and Correction,**  
9 **through the Community Corrections Act, of a 407 grant for State Fiscal Year 2015, in the**  
10 **amount of \$1,239,107.00, with no local cash match requirement, for community corrections**  
11 **programs to be operated by the Summit County Adult Probation Department and Oriana**  
12 **House, Inc., for the period 7/1/14 through 6/30/15, and appropriating expenses, for the**  
13 **Executive's Department of Law, Insurance and Risk Management – Division of Public**  
14 **Safety, and declaring an emergency.**

16 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (“ODRC”),  
17 through the Community Corrections Act (“CCA”) grant program, has renewed the award to the  
18 County of Summit of a 407 grant for State Fiscal Year (“SFY”) 2015, in the amount of  
19 \$1,239,107.00, with no local cash match requirement, for community corrections programs to be  
20 operated by the Summit County Adult Probation Department and Oriana House, Inc., for the  
21 period 7/1/14 through 6/30/15, and

23 WHEREAS, it is necessary for the County Executive to execute documents necessary to  
24 accept the grant award and to appropriate expenses; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
28 execute any documents necessary to accept the CCA 407 grant funds in the amount of  
29 \$1,239,107.00, with no local cash match requirement, for SFY 2015, and to appropriate  
30 expenses;

38 the award from the State of Ohio Department of Rehabilitation and Correction (“ODRC”),

40 Year (“SFY”) 2015, in the amount of \$1,239,107.00, with no local cash match requirement, for  
41 community corrections programs to be operated by the Summit County Adult Probation  
42 Department and Oriana House, Inc., for the period 7/1/14 through 6/30/15.
